



ORDINANCE 1049

AN ORDINANCE AMENDING AND CHANGING THE ZONING MAP OF THE CITY OF REXBURG, IDAHO, AND PROVIDING THAT THE ZONED DESIGNATION OF THAT CERTAIN PROPERTY HEREINAFTER DESCRIBED, SITUATED IN REXBURG, MADISON COUNTY, IDAHO, BE CHANGED AS HEREINAFTER DESIGNATED; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.

BE IT ORDAINED BY the City of Rexburg, Idaho:

SECTION I: That the zoning map of the City of Rexburg, Idaho, which is filed with the city clerk thereof, be, and the same is hereby amended and changed to provide that the hereinafter described property situated in the City of Rexburg, Madison County, State of Idaho, be rezone from LDR2 to LDR3 as follows:

Commencing at the east quarter corner of Section 26, Township 6 North, Range 39 E.B.M., Madison County, Idaho, and running thence South 89° 45' 40" West 465.00 feet; thence South 00° 22' 09" East 468.39 feet; thence South 89° 45' 44" West 95.00 feet; thence South 00° 22' 09" East 21.45 feet to the point of beginning; thence South 00° 22' 09" East 608.56 feet; thence South 89° 49' 45" West 887.76 feet; thence North 00° 00' 43" East 607.53 feet; thence North 89° 45' 44" East 883.71 feet to the point of beginning.

SECTION II: That a new zoning map showing these amendments shall be certified to and declared to be the official zoning map of the City of Rexburg by passage of this Ordinance by the City Council of the City of Rexburg.

SECTION III: This ordinance shall become effective upon its passage, approval and publication.
