



ORDINANCE NO. 293

AN ORDINANCE TERMED THE ANNUAL APPROPRIATION BILL OF THE CITY OF REXBURG, LEVYING TAXES FOR GENERAL REVENUE PURPOSES AND FOR INTEREST ON BONDED INDEBTEDNESS, AND APPROPRIATING SUCH SUMS OF MONEY FOR THE VARIOUS PURPOSES AS ARE DEEMED NECESSARY TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES OF SAID CITY DURING THE ENSUING FISCAL YEAR.

BE IT ORDAINED by the Mayor and Council of the City of Rexburg:

SECTION I: That this ordinance be termed the Annual Appropriation Bill of the City of Rexburg.

SECTION II: That there is hereby levied upon all taxable property within the City of Rexburg taxes for the several purposes as follows:

For general revenue purposes fifteen mills on the dollar.

For interest on the outstanding general obligation bonds of the city seven mills on the dollar.

The City Treasurer is hereby directed to apportion all moneys received on account of said levies to the respective funds for which levied as aforesaid.

SECTION III: That the revenue of the City of Rexburg for the fiscal year 1927, from all sources, is hereby appropriated to the various purposes in the several amounts following, which are hereby deemed necessary for such purpose, to-wit:

- A. From moneys received on account of taxes levied therefore there is hereby appropriated for general revenue purposes the sum of \$20,200.00;
- B. From moneys received on account of taxes levied therefore there is hereby appropriated for payment of interest on outstanding general obligation bonds of the city the sum of \$7,500.00;
- C. From the receipts from the waterworks system of the City for the fiscal year 1927 and from the money now on hand in the Waterworks Fund, there is hereby appropriated the amount necessary to defray the expenses of operation and maintenance of said system during said fiscal year, and from said receipts there is also hereby appropriated the sum of \$1,850.00 for the sinking fund and for interest on waterworks bonds;
- D. From the receipts of the ditch system of the City for the fiscal year 1927, there is hereby appropriated sufficient funds for the operation and maintenance of said ditch system;
- E. All money received from the sale of lots in the City Cemetery, and all money received from the care of lots in the City Cemetery, is hereby appropriated the Cemetery Fund;
- F. All money received from the road poll tax, county road and bridge tax, during the fiscal year 1927, is hereby appropriated to the Road & Bridge Fund;
- G. All revenues of the City of Rexburg for the fiscal year 1927, not herein otherwise appropriated, are hereby appropriated to the General Expense Fund of said city.

SECTION IV: This ordinance shall take effect and be in full force from and after its passage and approval, and upon its publication in the Rexburg Standard, a weekly newspaper printed and published in the City of Rexburg, and having a general circulation herein.
