



**ORDINANCE NO. 312**

**AN ORDINANCE FIXING THE SALARIES AND TIMES OF PAYMENT THEREOF OF THE MAYOR, COUNCILMEN, CITY CLERK, CITY TREASURER, CITY ATTORNEY, CITY PHYSICIAN, CHIEF OF POLICE, SUPERINTENDENT OF WATER WORKS, POLICE JUDGE, CHIEF OF FIRE DEPARTMENT, ASSISTANT CHIEF OF FIRE DEPARTMENT AND PROBATION OFFICER OF THE CITY OF REXBURG, AND REPEALING ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH: AND FIXING THE TIME OF TAKING EFFECT HEREOF.**

BE IT ORDAINED By the Mayor and Council of the City of Rexburg, Idaho:

**SECTION I:** The salaries and compensation and times of payment thereof of the officers, electives and appointive, of the city of Rexburg, Idaho, are hereby fixed as follows:

The salary of the Mayor shall be One Hundred Eighty Dollars per year, and shall be paid quarterly;

The salaries of councilmen shall be Ninety Dollars per year, and shall be paid quarterly;

The salary of the City Clerk shall be Nine Hundred Dollars per year, and shall be paid semi-monthly;

The salary of the City Treasurer shall be Three Hundred Dollars per year, and shall be paid semi-monthly;

The salary of the City Attorney shall be Three Hundred Eighty-four Dollars per year, and shall be paid quarterly;

The salary of the City Physician shall be One Hundred Dollars per year, and shall be paid quarterly;

The salary of the Chief of Police shall be Twelve Hundred Dollars per year, and shall be paid quarterly;

The salary of the Superintendent of Water Works shall be Twelve Hundred Dollars pr year, and shall be paid semi-monthly;

The salary of the Polices Judge shall be Two Hundred Forty Dollars per year, and shall be paid monthly;

The salary of the Chief of the Fire Department shall be Twelve Hundred Dollars per year, and shall be paid semi-monthly;

The salary of the Assistant Chief of the Fire Department shall be Eleven Hundred Dollars per year, and shall be paid semi-monthly;

The salary of the Probation Officer shall be Two Hundred Eight-eight Dollars per year, and shall be paid semi-monthly;

**SECTION II:** This ordinance shall take effect and be in force on and after the first day of May, 1933.

**SECTION III:** All ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
