



ORDINANCE NO. 357

AN ORDINANCE VACATING AND CLOSING A CERTAIN PORTION OF MAIN STREET ADJOINING BLOCKS THREE AND FOUR OF THE RIGBY ADDITION TO THE STREET LYING WEST OF THE NORTH HALF OF BLOCK THREE OF THE RIGBY ADDITION TO THE CITY OF REXBURG, IDAHO FOR THE SOLE AND EXCLUSIVE USE OF THE OWNERS OF THE ADJACENT REAL ESTATE, AS PROVIDED BY LAW.

WHEREAS, the Madison County Memorial Hospital Committee has requested of the City Council to vacate and close a portion of Main street adjoining blocks three and four of the Rigby addition to the City of Rexburg, Idaho, on the North, and that part of South fourth East Street lying West of the North half of block three of the Rigby addition to the City of Rexburg, Idaho, for the sole and exclusive use of the owners of the adjacent real estate, as provided by law,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF REXBURG, IDAHO:

SECTION I: That a certain portion of Main street adjoining block 3 and 4 of the Rigby addition to the City of Rexburg, Idaho, of the North, and that part of south 4th East street lying West of the North half of block 3 of the Rigby Addition to the City of Rexburg, Idaho, and more particularly described as follows:

Commencing at the Northeast corner of block 2 of the Rigby Addition to the City of Rexburg, in Madison County, State of Idaho, which point of beginning is 66 feet south and 1468 2 feet east of the North west corner of Section 29, in township 29, in township 6 North, Range 40 East, Biose Meridian, and running thence south 330 feet; thence East 1171 2 feet, to the East line of the Northwest Quarter of said section 29; thence North 132 feet; thence West 1270 2 feet; thence south 132 feet to the place of beginning, same being a part of the NW 1/4 of said Section 29 and all of the South 66 feet of the East 1270 2 feet of the SW 1/4 of section 20 in the aforesaid Township and Range, and also more particularly described as one half (2) block of South 4Th East street running South from East Main Street, Of the City of Rexburg, be, and the same are hereby vacated and closed for the sole and exclusive use of the owners of the adjacent real estate, as provided by the statutes of the State of Idaho and Mayor and City Clerk are directed to execute to the said owners in the name of the City of Rexburg, Idaho, Quit claim deeds to that portion of said streets as provided by law.

SECTION II: This Ordinance shall take effect and be in full force and effect from and after its passage, approval, and due publication, as provided by law.
