



**ORDINANCE NO. 377**

**AN ORDINANCE ENTITLED THE ANNUAL APPROPRIATION BILL OF THE CITY OF REXBURG, IDAHO, FOR THE FISCAL YEAR 1951: LEVYING TAXES FOR GENERAL REVENUE PURPOSES OF SAID CITY AND FOR INTEREST ON THE BONDED INDEBTEDNESS AND FOR SINKING FUND: AND APPROPRIATING TO THE SEVERAL DEPARTMENTS, OFFICES AND FUNDS OF THE SAID CITY GOVERNMENT SUCH SUMS AS MAY BE NECESSARY ORDERED NECESSARY, BY THE MAYOR AND CITY COUNCIL, TO DEFRAID THE EXPENSES AND LIABILITIES OF SAID CITY FOR THE YEAR 1951.**

AND BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF REXBURG, IDAHO:

**SECTION I:** This ordinance shall be and is hereby termed THE ANNUAL APPROPRIATION BILL of the City of Rexburg, Idaho, for the year 1951.

**SECTION II:** There is hereby levied upon all taxable property within the City limits of the City of Rexburg, and subject to taxation for the City purposes of said City Government at the rates following:

For General Revenue purposes ten (10) mills on each dollar of assessed valuation.

For streets and Alleys special fund six (6) mills on each dollar of assessed valuation.

For Municipal Health and Sanitation special fund One (1) mill on each dollar of assessed valuation.

For City Park Fund three (3) mills on each dollar of assessed valuation.

For Municipal Library Fund one (1) mill on each dollar of assessed valuation.

For Police Retirement Fund one-half (.50) mill on each dollar of assessed valuation.

For Municipal Airport Fund one-half (.50) mill on each dollar of assessed valuation.

For Municipal Bond Interest and Sinking Fund three (3) mills on each dollar of assessed valuation.

For Municipal Special Improvement District Guarantee Fund one mill (1) on each dollar of assessed valuation.

For Municipal Fire Department Fund two (2) mills on each dollar of assessed valuation.

**SECTION III:** The clerk is hereby empowered and directed to certify the foregoing to the proper officers of Madison County Idaho, for entry upon the tax rolls of said County for collection in proper manner provided by law.

**SECTION IV:** The City Treasurer is hereby empowered and directed to apportion the moneys received on account of taxes hereby levied, and from all other sources, to the several funds for which levies are made and to which moneys are appropriated as in this ordinance provided.

**SECTION V:** The revenue for the City of Rexburg, Idaho, for the fiscal year 1951 from all sources received are hereby appropriated to the several Funds and purposes which are hereby

declared to be necessary for such purposes as shown by the budget of the City heretofore adopted for said fiscal year, respectively, as follows, to-wit:

**A. GENERAL EXPENSE FUND:** From moneys received on account of taxes levied, and other available sources, there is hereby appropriated to the General Expense Fund (Administrative, Sundries, Law Enforcement, Waterworks, and Irrigation Depts.) the sum of \$76,459.80.

**B. STREETS AND ALLEYS DEPARTMENT:** From moneys received on account of taxes levied thereof there is hereby appropriated to the Streets Department the sum of \$28,880.00.

**C. MUNICIPAL HEALTH AND SANITATION FUND:** From the moneys received on account of taxes levied thereof, there is hereby appropriated to the Health and Sanitation Department the sum of \$7,645.00.

**D. MUNICIPAL LIBRARY FUND:** From moneys received on account of taxation, there is hereby appropriated to the Library Department, the sum of \$1,020.00

**E. MUNICIPAL PARKS FUND:** From the moneys received on account of taxation, there is hereby appropriated to the Park Department the sum of \$5,660.00.

**F. STREET FIGHTING DEPARTMENT:** From the moneys received on account or taxation there is hereby appropriated to the Street Light Department the sum of \$4,000.00.

**G. MUNICIPAL AIRPORT FUND:** From moneys received from taxation and other available sources, there is hereby appropriated to the Airport Fund the sum of \$1,500.00.

**H. BOND INTEREST AND SINKING FUND:** From moneys received on account of taxes levied and other available sources, there is hereby appropriated to the Bond Interest and Sinking Fund, for the payment of interest on outstanding Bonds and for the payment of maturing installments on such indebtedness, the sum of \$5,600.00.

**I. POLICE RETIREMENT FUND:** From moneys on account of taxation there is hereby appropriated to the Police Retirement Fund the sum of \$730.49.

**J. MUNICIPAL SPECIAL IMPORVEMENT DISTRICT FUND:** From the moneys received on account of taxes levied, there is hereby appropriated to the Special Improvement Fund, the sum of \$1,460.97.

**K.** All revenues of the City of Rexburg received during the fiscal year 1951 not hereby otherwise appropriated, are hereby appropriated to the General Fund of the City.

**SECTION VI:** This ordinance shall take effect and be in force from and after its passage and publication as required by law.
