



ORDINANCE NO. 473

AN ORDINANCE REPEALING ORDINANCE NO. 459 AND SECTIONS 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 21, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, and 38 OF ORDINANCE NO. 358 OF THE CITY OF REXBURG, IDAHO, AND ADOPTING THE "UNIFORM BUILDING CODE, 1967 EDITION, COPYRIGHTED BY INTERNATIONAL CONFERENCE OF BUILDING OFFICIALS," WITH CERTAIN EXCEPTIONS, AS THE BUILDING CODE OF THE CITY OF REXBURG, IDAHO, PROVIDING THAT THREE COPIES THEREOF SHALL BE HEREAFTER KEPT ON FILE IN THE OFFICE OF THE CITY CLERK; REPEALING ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith, PROVIDING WHEN THE ORDINANCE SHALL BECOME EFFECTIVE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I: That Ordinance No. 459 and Section 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, and 38, of Ordinance No. 358 be, and the same are hereby repealed, The remaining sections of said Ordinance No. 358, to-wit: Section 7, 11, and all amendments thereto, 39, 40, and 41, to remain in full force and effect.

SECTION II: A certain document, with exceptions hereinafter set forth, consisting of one (1) volume, being Volume I of the Uniform Building Code, 1967 Edition, by International Conference of Building Officials, is being marked and fully certified as the Uniform Building Code of the City of Rexburg, That such building code regulated the erection, construction, enlargement, alteration, repair, moving, removal, demolition, conversion, occupancy, equipment, use, height, area and maintenance of all buildings and/or structures in the City of Rexburg, Idaho. All permits shall be issued, fees collected and penalties established as provided therein, except as to Sub-Section (b) and Table No. 3-A Building Permit Fees of Section 303 of said Uniform Building Code, which Sub-section (b) and Table 3-A Building Permit Fees of said Section 303 of said Uniform Building Code, which Sub-section (b) and Table No. 3-A Building Permit Fees of said Section 303, are not adopted as the City of Rexburg, Idaho, building fee schedule; Section 7, Ordinance No. 358, City of Rexburg, Idaho, shall remain in full force and effect as the Building Permit Fees of the City of Rexburg, Idaho. The appendix, Sections 1313 to 7020 and any portions of said Uniform Building Code in conflict with Section 7, 11, and all amendments thereto, 39, 40, and 41 of Ordinance No. 358, are not adopted; that the remaining terms of such Uniform Building Code, 1967 Edition, by International Conference of Building Officials on file in the office of the City Clerk are hereby referred to, adopted, and made a part hereof as though fully set forth herein. That three (3) copies of said Volume I of the Uniform Building Code, 1967 Edition, by International Conference of Building Officials are on file in the office of the City Clerk

SECTION III: All Ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION IV: This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
