



**ORDINANCE NO. 584**

**AN ORDINANCE ESTABLISHING THE PRECINCT BOUNDARIES OF THE ELECTION PRECINCTS WITHIN THE CITY OF REXBURG, IDAHO; PARTICULARLY DESCRIBING SAID BOUNDARIES, REPEALING ORDINANCE NO. 47 AND ALL OTHER ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE; PROVIDING WHEN THE ORDINANCE SHALL BECOME EFFECTIVE.**

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

**SECTION I:** Ordinance No. 47 of the City of Rexburg, Idaho, and all other ordinances and parts of ordinances in conflict herewith, are hereby repealed.

**SECTION II: ELECTION PRECINCTS.** The City of Rexburg shall be divided into four (4) precincts which shall each and respectively comprise that portion of the City set forth as follows:

- A. ELECTION PRECINCT NO. 1 shall comprise and include all that part of the City described as follows:

Beginning at the point of intersection of the center line of main Street and the center line of Center Street, thence North along the center line of North Center Street to its intersection with the Union Pacific Railroad track; thence following said railroad track in a Northeasterly direction to the city limits boundary line; thence East to Highway 191; thence South to the point of intersection of Highway 191 with the Teton River; thence following the meanderings of the Teton River to its intersection with the East boundary of the city limits; thence South along the East city limits boundary line to the point of intersection of Fourth East Street; thence East along the North city limits boundary line to its point of intersection with the East city limits boundary line; thence South along the East city limits boundary line to the point of intersection with the center line of East Main Street; thence West along the center line of Main Street to the point of beginning.

- B. ELECTION PRECINCT NO. 2 shall comprise and include all that part of the City of Rexburg described as follows:

Beginning at the point of intersection of the center line of Main Street and the center line of Center Street; thence North along the center line of North Center Street to its intersection with the Union Pacific Railroad track; thence in a Southwesterly direction along said track to its intersection with the North boundary of the city limits; thence West along the North city limits boundary line to its point of intersection with the West city limits boundary line; thence South along the West city limits boundary line to its intersection with the center line of West Main Street; thence West along the center line of West Main Street to the point of its intersection with the West boundary of the city limits; thence South along said West boundary of the city limits to its intersection with the South boundary of the city limits; thence East along said South boundary of the city limits to its intersection with the West boundary of said city limits; thence South along said West boundary to its intersection with the South boundary of the city limits; thence East along the South boundary of the city limits to its intersection with the West boundary to the city limits; thence South along said West boundary to its point of intersection with the East side of the Union Pacific Railroad right of way; thence Northeasterly along said right of way to its intersection with the center line of Second South Street; thence East along the center line of Second South Street to its point of intersection with the center line of Second West Street; thence North along the center line of Second West Street to its intersection with the center line of West Main Street; thence East along the center line of West Main Street to the point of beginning.

- C. ELECTION PRECINCT NO. 3 shall comprise and include all that part of the City of Rexburg described as follows:

Beginning at the point of intersection of the center line of Main Street and the center line of Center Street; thence East along the center line of Main Street to its intersection with the center line of First East Street; thence South along the center line of First East Street to its intersection with the center line of Second South Street; thence East along the center line of Second South Street to its intersection with the center line of Second East Street; thence South along the center line of Second East Street to its intersection with the South boundary of the city limits; thence West along the South boundary of the city limits to its intersection with the East side of the Union Pacific Railroad right of way; thence Northeasterly along said right of way to its intersection with the center line of Second South Street; thence East along the center line of Second South Street to its intersection with the center line of Second West Street; thence North along the center line of Second West Street to its intersection with the center line of West Main Street; thence East along the center line of West Main Street to the point of beginning.

- D. ELECTION PRECINCT NO. 4 shall comprise and include all that part of the City of Rexburg described as follows:

Beginning at the point of intersection of the center line of East Main Street and the center line of First East Street; thence East along the center line of East Main Street to its intersection with the East boundary of the city limits; thence South along the East boundary of the city limits to its intersection with the South boundary of the city limits; thence West along the South boundary of the city limits to its intersection with the center line of Second East Street; thence North along the center line of Second East Street to its intersection with the center line of Second South Street; thence West along the center line of Second South Street to its intersection with the center line of First East Street; thence North along the center line of First East Street to the point of beginning.

**SECTION III:** This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
