



ORDINANCE NO. 673

AN ORDINANCE REPEALING SECTIONS II, III, IV AND V OF ORDINANCE NO. 653 AND ADOPTING THE UNIFORM PLUMBING CODE, COPYRIGHTED BY THE INTERNATIONAL ASSOCIATION OF PLUMBING AND MECHANICAL OFFICIALS, 1985 EDITION, FOR THE CITY OF REXBURG, IDAHO; REQUIRING COPIES OF SAID CODE TO BE KEPT IN THE OFFICE OF THE CITY CLERK; PROVIDING FOR THE ADMINISTRATIVE AUTHORITY AND THE PAYMENT OF FEES ESTABLISHED BY THE COUNCIL; PROVIDING FOR A PENALTY FOR THE VIOLATION OF THIS ORDINANCE AND FOR SEVERABILITY; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I: That Sections II, III, IV and V of Ordinance No. 653 is hereby repealed.

SECTION II: That the document known as the Uniform Plumbing Code, copyrighted by the International Association of Plumbing and Mechanical Officials, 1985 Edition, together with the amendments and revisions thereof, with the inclusion of appendices, is hereby adopted as the plumbing code of the City of Rexburg, Idaho. Said Code provides the minimum requirements and standards for the protection of public health, safety and welfare, and the provisions of the Code shall apply to the erection, installation, alteration, addition, repair, relocation, replacement, maintenance or use of any plumbing system except as otherwise provided in said Code.

SECTION III: There has been on file, and there shall hereafter be kept on file, in the office of the Clerk three (3) copies of said Uniform Plumbing Code, 1985 Edition, duly certified by the Clerk, for use and examination by the public.

SECTION IV: The administrative authority shall be the City Council of the City of Rexburg, Idaho, and such authority may appoint and employ such assistants, deputies, inspectors or other employees as are necessary and authorized to carry out the functions of said Code.

SECTION V: All applicants shall pay to the City Clerk fees established by the Council.

SECTION VI: Any person, firm or corporation violating any provision of this Chapter shall, upon conviction thereof, be punishable by a fine not to exceed Three Hundred Dollars (\$300.00) or by imprisonment for not more than six (6) months or by both such fine and imprisonment for any single violation.

SECTION VII: The sections of this Ordinance are severable and the invalidity of a section shall not affect the validity of the remaining sections.

SECTION VIII: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION IX: This Ordinance shall become effective upon its passage, approval and publication in the manner provided by law.
