ORDINANCE NO. 703

AN ORDINANCE VACATING AND CLOSING A CITY ALLEY IN THE MILL HOLLOW SUBDIVISION IN THE CITY OF REXBURG, IDAHO; PROVIDING THAT SAID ALLEY REVERT TO THE OWNERS OF THE ADJACENT REAL ESTATE ON THE EAST AND WEST OF SAID ALLEY; AND PROVIDING WHEN SAID ORDINANCE SHALL TAKE EFFECT.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I: That it is deemed expedient for the public good that the following described platted city alley of the City of Rexburg, Idaho, to-wit:

That portion of the Alley directly easterly and at right angles to Lot 3 and those portions of the Alley between Lots 4 and 5, 6 and 7, 8 and 9, 10 and 11, 12 and 13, 14 and 15, and between Lots 16 and 17. All Lots are within the Mill Hollow Subdivision, City of Rexburg, Madison County, Idaho.

be, and the same is hereby vacated, closed and discontinued. The Council deems it in the best interests of the adjoining properties that all of said city alley so vacated revert one-half thereof to the owners of the adjacent real estate on the east and west of said city alley. The Mayor and City Clerk are directed to execute and deliver to said adjacent property owners on the east and west, in the name of the City of Rexburg, Quitclaim Deeds to the center of said city alley abutting said property for the distance of each property boundary of said alley.

SECTION II: That said city alley so vacated is not necessary for the use of the City of Rexburg, Madison County, Idaho, and is not required for any city purposes.

SECTION III: This ordinance shall take effect and be in full force and effect from and after its passage, approval and due publication as provided by law.
