



ORDINANCE NO. 716

AN ORDINANCE AMENDING AND CHANGING THE MAP OF THE CITY OF REXBURG, IDAHO, AND PROVIDING THAT THE ZONED DESIGNATIONS OF THAT CERTAIN PROPERTY HEREINAFTER DESCRIBED, SITUATE IN REXBURG, MADISON COUNTY, IDAHO, BE CHANGED AS HEREINAFTER DESIGNATED: AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I: That the zoning map of the City of Rexburg, Idaho, which is filed with the clerk thereof, be, and the same is hereby amended and changed to provide that the hereinafter described property situate in Rexburg, Madison county, State of Idaho, be zoned as hereinafter set forth.

A. The following described property located in Rexburg, Madison County, Idaho, is hereby zoned R-3:

TRACT 1: (30 West 200 South)

Commencing at a point eleven rods West of the Southeast Corner of Lot 4, Block 48 of the Original Rexburg Townsite, Madison County, Idaho, as per the recorded plat thereof, and running thence North 165 feet; thence West 8 feet; thence South 165 feet; thence East 8 feet to the point of beginning.

TRACT 2:

Commencing at a point 189 1/2 feet West of the Southeast corner of Lot 4, Block 48, of the Original Rexburg Townsite, Rexburg, Madison County, Idaho, as per the recorded plat thereof, and running thence North 165 feet; thence West 58 feet; thence South 165 feet; thence East 58 feet to the point of beginning.

TRACT 3: (22 West 200 South)

Commencing at a point 7 rods West of the Southeast corner of Lot 4, Block 48 of the Original Rexburg Townsite, Madison County, Idaho, as per the recorded plat thereof, and running thence North 7 rods; thence West 4 rods; thence South 7 rods; thence East 4 rods to the point of beginning.

SECTION II: That a new zoning map showing this amendment shall be certified to and declared to be the official zoning map of the City of Rexburg by a certificate of the Mayor and Council of the City of Rexburg endorsed thereon.

SECTION III: This ordinance shall become effective upon its passage, approval and publication.
