



ORDINANCE NO. 756

AN ORDINANCE AMENDING ORDINANCE NO. 755 CORRECTING THE LEGAL DESCRIPTION OF THE LANDS ANNEXED TO THE CITY OF REXBURG, IDAHO; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, AS FOLLOWS:

SECTION I: That the legal description contained in Section I. of Ordinance 755 adopted on February 2, 1994, be amended and corrected to read as follows:

"Tract 1. The North 42 rods of the Northwest Quarter of Section 25, Township 6 North, Range 39 East, Boise Meridian, Madison County, Idaho. EXCEPTING THEREFROM: Commencing at the Northeast corner of the Northwest Quarter of Section 25, Township 6 North, Range 39 East, aforesaid, and running thence South 330 feet, thence West 120 feet, thence North 330 feet, thence East 120 feet to the place of beginning.

Together with a right of way described as follows: Commencing at the Northeast corner of the Northwest Quarter of Section 25, Township 6 North, Range 39 East, Boise Meridian, and running thence South 330 feet, thence West 16.5 feet, thence North 330 feet, thence East 16.5 feet to the place of beginning. Less that portion heretofore deeded to the State of Idaho in the Second Judgment and Decree of Condemnation recorded March 14, 1981, as Instrument No. 202915, in the records of Madison County, Idaho.

TRACT 2: Commencing at the Northeast corner of the Northwest Quarter of Section 25, Township 6 North, Range 39 East, Boise Meridian, Madison County, Idaho, and running thence South 330 feet, thence West 120 feet, thence North 330 feet, thence East 120 feet to the place of beginning.

Subject to a right of way described as follows: Commencing at the Northeast corner of the Northwest Quarter of said Section 25, and running thence South 330 feet, thence West 16.5 feet, thence North 330 feet, thence East 16.5 feet to the point of beginning.

EXCEPTING from both tracts any property lying west of U.S. 20."

SECTION II: That all other sections of Ordinance 755 shall remain in full force and effect, amended only by the correction in the foregoing legal description of the real property annexed to the City.

SECTION III: This ordinance shall be in full force and effect from and after its passage, approval and due publication.
