



ORDINANCE NO. 757

AN ORDINANCE AMENDING AND CHANGING THE ZONING MAP OF THE CITY OF REXBURG, IDAHO, AND PROVIDING THAT THE ZONED DESIGNATION OF THAT CERTAIN PROPERTY HEREINAFTER DESCRIBED, SITUATE IN REXBURG, MADISON COUNTY, IDAHO, WHICH HAS HEREINAFTER DESIGNATED; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I: That the zoning map of the City of Rexburg, Idaho, which is filed with the clerk thereof, be, and the same is hereby amended and changed to provide that the hereinafter described property situate in Rexburg, Madison County, State of Idaho, be zoned as hereinafter set forth.

- A. The following described property located south of West Main and west of the Starlite Addition and Parkview Additions, in Rexburg, Madison County, Idaho, which has not previously been zoned, is hereby zoned LDR-1:

Commencing at a point 80 feet East of the Northeast Corner of the Southeast Quarter of the Northwest Quarter of Section 25, Township 6 North, Range 39 East, Boise Meridian, Madison County, Idaho, and running thence East 549 feet; thence South 20 rods; thence West 549 feet; thence North 20 rods to the point of beginning.

Commencing at a point that is 198 feet South of the Northeast corner of the Northwest Quarter of the Northeast Quarter of Section 25, Township 6 North, Range 39 East, Boise Meridian, and running thence West 415 feet; thence North 198 feet; thence West 575 feet; thence South 660 feet; thence West 330 feet; thence South 660 feet; thence East 1320 feet; thence North 1122 feet to the point of beginning.

SECTION II: That a new zoning map showing this amendment shall be certified to and declared to be the official zoning map of the City of Rexburg by a certificate of the Mayor and Council of the City of Rexburg endorsed thereon.

SECTION III: This ordinance shall become effective upon its passage, approval and publication.
