**SUMMARY OF ORDINANCE 850  
OF THE CITY  
OF REXBURG, IDAHO**

PUBLIC NOTICE IS HEREBY GIVEN that the City of Rexburg, Idaho, adopted at its regular meeting of March 21, 2001, that Ordinance No. 850 entitled:

**AN ORDINANCE CONCERNING THE IMPROVEMENTS IN, ASSESSMENTS AGAINST PROPERTY IN, AND REGISTERED WARRANTS FOR LOCAL IMPROVEMENT DISTRICT NO. 31, FOR THE PURPOSE OF CAUSING CERTAIN STREETS AND PARTS THEREOF WITHIN THE CORPORATE LIMITS OF SAID CITY TO BE GRADED, RE-GRADED, GRAVELED, PAVED, RE-PAVED AND OTHERWISE IMPROVE CERTAIN STREETS WITHIN THE DISTRICT AND TO CONSTRUCT AND RECONSTRUCT SIDEWALKS, CURBS, GUTTERS, DRIVEWAYS, DRAINAGE FACILITIES, OFF-SITE STORM SEWER, AND OTHER WORKS INCIDENTAL TO ALL OF THE FOREGOING IMPROVEMENTS WITHIN SAID DISTRICT, AND PROVIDING WHEN THIS ORDINANCE SHALL BE IN EFFECT.**

The effective date of the Ordinance is the date of its passage, approval and publication. A copy of the full text of the Ordinance is available at City Hall, 12 North Center, Rexburg, Idaho. Examination or copies may be requested in writing or in person during regular business hours of the City Clerk, from 8 a.m. to 4 p.m. pursuant to the Open Records Act, Idaho Code, Title 9, Chapter 3.
