Resolution 11-16-1960 (2)

A RESOLUTION FIXING THE TIME WHEN OBJECTIONS TO THE ASSESSMENT ROLL FOR LOCAL IMPROVEMENT DISTRICT NO. 5 MADE OUT BY THE COMMITTEE ON SANITATION OF THE CITY COUNCIL, TOGETHER WITH THE CITY ENGINEER, WILL BE HEARD, AND CAUSING SUCH ROLL TO BE FILED IN THE OFFICE OF THE CITY CLERK.

WHEREAS, the committee on sanitation of the City Council of the City of Rexburg, together with the City Engineer, has made out an assessment roll for Local Improvement District No. 5 for Construction and installation of sanitary sewer laterals in the City of Rexburg, Idaho, in accordance with the provisions of Ordinance No. 417, passed and approved the 8th day of May, 1960, and Section 50-2915, Idaho Code, has certified said roll to said City Council, and

WHEREAS, said City Council has caused said assessment roll to be filed in the office of the City Clerk on the 16th day of November, 1960,

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF REXBURG, IDAHO:

Section 1. That Wednesday, the 7th day of December 1960, at 8 o'clock p.m. at the City Hall in the City of Rexburg, Idaho, be, and the same is hereby fixed as the time when the City Council will hear and consider objections to said assessment roll by parties aggrieved by such assessments.

Section 2. That the City Clerk shall give notice by publication on the official newspaper of the City of Rexburg, Idaho, the Rexburg Standard, published weekly, in at least on issue, at least twelve days before he said 7th day of December 1960, that such assessment roll is on file in her office the date of filing the same, and said notice shall state the time at which the council will hear and consider objections to said assessment roll by the parties aggrieved by such assessments. Said notice shall be in the following form, to wit:

NOTICE IS HEREBY GIVEN that the assessment roll for Local Improvement District No. 5 for the construction and installation of sanitary sewer laterals in the City of Rexburg, Idaho, was filed in my office on the 16th day of November, 1960, and is now on file herein.

The owner or owners of any property which is assessed in said assessment roll, whether named or not in said roll, may, within ten days from the first publication of this Notice, on November 17, 1960, file with me his objections in writing to said assessment.

The City Council will meet to hear and consider objections to said assessment roll by the parties aggrieved by such assessments on Wednesday, the 7th day of December, 1960 at 8 o'clock p.m. at the City hall in the City of Rexburg, Idaho.
