



**ORDINANCE NO. 324**

**AN ORDINANCE ENTITLED "THE ANNUAL APPROPRIATION BILL OF THE CITY OF REXBURG" LEVYING TAXES FOR GENERAL REVENUE PURPOSES OF SAID CITY AND INTEREST ON THE BONDED INDEBTEDNESS THEREOF AND SINKING FUND, AND APPROPRIATING SUCH SUMS OF MONEY AS ARE NECESSARY OR DEEMED NECESSARY BY THE MAYOR AND COUNCIL OF SAID CITY, TO DEFRAY THE EXPENSES AND LIABILITIES OF SAID CITY FOR THE FISCAL YEAR 1935.**

BE IT ORDAINED By the Mayor and Council of the City of Rexburg, Idaho:

**SECTION I:** This Ordinance shall be and is hereby termed "The Annual Appropriation Bill of the City of Rexburg" for the fiscal year 1935.

**SECTION II:** There is hereby levied upon all the taxable property within the limits of the City of Rexburg and subject to taxation for city purposes, in and for the year 1935, taxes for the server purposes and at the rates following:

For general revenue purposes, ten mills on each dollar of assessed value;

For interest on outstanding bonds of said City and sinking fund, ten mills on each dollar of assessed value.

**SECTION III:** The City Clerk is hereby authorized and directed to certify the foregoing levies to the proper officers of Madison County for entry upon the tax rolls of the County for collection in the manner provided by law.

**SECTION IV:** The City Treasurer is hereby directed to apportion the moneys received on account of taxes hereby levied, and for all other purposes, to the several funds for which said levy is made and to which said moneys are appropriated as in this Ordinance provided.

**SECTION V:** The revenues of the City of Rexburg for the fiscal year 1934, from all sources received, are hereby appropriated to the several funds and purposes respectively, as follows, which are hereby declared to be necessary for such purposes as shown by the budget of the City for said year, to-wit:

- A. General Expense Fund:** From moneys received on account of taxes levied and other available revenues, there is hereby appropriated to the General Expense Fund of the City Government, the sum of \$13,176.00.
- B. Water Department:** From revenues derived from the water works system of the City for the fiscal year 1935, and from moneys now on hand in the water works fund and other revenues available, there is hereby appropriated the amount necessary to defray the expenses of operation and maintenance of said system during the fiscal year 1935, and from such revenues and for said purposes there is hereby appropriated the sum of \$5,800.00.
- C. Streets Department:** From moneys received on account of taxes levied therefore, and other revenues available, there is hereby appropriated to the Streets Department of the City for maintenance and improvement of public streets, alleys, parks and public grounds the sum of \$3,940.00.
- D. Fire Department:** From moneys received on account of taxes levied therefore and other revenues available, there is hereby appropriated to the Fire Department of said

City for the purposes of paying salaries and other expenses of operation and maintenance the sum of \$2,980.00.

- E. Ditch Department:** All moneys received from and on account of the irrigation system of said City and the distribution of water thereby to the inhabitants of the City are hereby appropriated to the Ditch Fund for the payment of salaries, wages and other necessary expenses of operation and maintenance of the irrigation system, and there is also hereby appropriated to the Ditch Fund for the several purposes needed the additional sum, from moneys not other-wise appropriated, of \$1,000.00.
- F. Police Department:** From moneys received on account of taxes levied therefore, and other revenues available, there is hereby appropriated to the Police Department Fund for the payment of salaries and other necessary expenses, the sum of \$3,780.00.
- G. Interest and Sinking Fund:** From moneys levied on account of taxes levied therefore, and other revenues available, there is hereby appropriated for the payment of interest on outstanding general obligation bonds of the City, and for the Sinking Fund therefore, the sum of \$11,000.00.
- H.** All revenues of the City of Rexburg received during the fiscal year 1935 not hereby otherwise appropriated are hereby appropriated to the General Fund of the City.

**SECTION VI:** This Ordinance shall take effect and be in forces from and after its passage, approval and due publication as required by law.
