



ORDINANCE NO. 356

AN ORDINANCE AMENDING ORDINANCE NO. 260, REGULATING THE USE OF THE SEWERAGE SYSTEM OF THE CITY OF REXBURG, MADISON COUNTY, IDAHO, AND PROVIDING A CHANGE IN THE PRICE OF THE APPLICATION FOR A PERMIT FOR CONNECTIONS WITH SAID SEWER SYSTEM:

BE IT ORDAINED BY THE CITY OF REXBURG, IDAHO:

SECTION I: That Section 2, of Ordinance No. 260 of the City of Rexburg, Idaho be amended and made to read as follows, to wit:

Applications for permit for sewer connections for each user proposing to use such sewer, must be made in writing by the owner of the premises, or his authorized agent and must be accompanied by a plan, showing the cause of the connection, its size and the size and location of all branches to be connected with it. The application and plan together with the fee of \$25.00 shall be deposited with the superintendent of sewers, which plan shall be examined by the superintendent of sewers, and if in his judgment the carrying out of the plan will cause no injury to the street in which the sewer sought to be connected with is laid, or to the carrying out of improvements projected, or which may thereafter be made on said street or prejudicial to the interests of persons whose property has been or thereafter be connected with the said sewer and that the said plan in all things does conform to the ordinances of this city, then the application to connect with the sewer will be granted subject to the provisions of this ordinances. All sewer connections shall be rut into line and grades designated by the City Engineer, who shall prepare a plat of each connection and file such plat in his office.

Whereas, an emergency hereby and herewith is declared to exist, this ordinance is therefor to take effect and be in force from and after its passing, approval and its publication.
