



ORDINANCE NO. 435

AN ORDINANCE ENTITLED THE ANNUAL APPROPRIATION BILL OF THE CITY OF REXBURG, IDAHO, FOR THE CALENDAR YEAR 1963, LEVYING TAXES FOR GENERAL REVENUE PURPOSES OF SAID CITY AND FOR INTEREST ON THE BONDED INDEBTEDNESS AND FOR SINKING FUND, AND APPROPRIATING TO THE SEVERAL DEPARTMENTS, OFFICES AND FUNDS OF THE SAID CITY GOVERNMENT SUCH SUFIS AS MAY BE NECESSARY OR DEEMED NECESSARY BY THE MAYOR AND CITY COUNCIL TO DEFRAID THE EXPENSES AND LIABILITIES OF SAID CITY FOR THE CALENDAR YEAR 1963.

BE IT ORDAINED BY THE CITY OF REXBURG, IDAHO:

SECTION I: This ordinance shall be and is hereby termed the annual appropriation bill of the City of Rexburg, Idaho, for the calendar year 1963.

SECTION II: There is hereby levied upon all taxable property within the city limits of the City of Rexburg, Idaho, and subject to taxation for the city purposes of said City Government at the rates following:

For general revenue purposes twenty -five (25) mills on each dollar of assessed valuation.

For interest on outstanding bonds of the City, and for sinking fund to pay maturing installments of such bonds, eight (8) mills on each dollar of assessed valuation.

For interest on Municipal Park Bonds of the City, and for sinking fund to pay maturing installments of such bonds, one and a half (1.50) mills on each dollar of assessed valuation.

For Police Retirement purposes one and one -half (1.50) mills on each dollar of assessed valuation.

For Local Improvement District Guarantee fund one (1) mill on each dollar of assessed valuation.

For Municipal Park purposes two (2) mills on each dollar of assessed valuation.

For Street lighting purposes one (1) mill on each dollar of assessed valuation.

SECTION III: The City Clerk is hereby empowered and directed to certify the foregoing to the proper officers of Madison County, Idaho, for entry upon the tax rolls of said County for the collection in the manner provided by law.

SECTION IV: The City Treasurer is hereby empowered and directed to apportion the moneys received on account of taxes hereby levied, and from all other sources, to the several funds for which levies are made and to which moneys are appropriated as in this ordinance provided.

SECTION V: The revenue for the City of Rexburg for the calendar year 1963 from all sources received are hereby declared appropriated to the several funds and purposes which are hereby declared to be necessary for such purposes as shown by the Budget of the City heretofore adopted for said calendar year, respectively, as follows, to -wit:

A. ADMINISTRATIVE DEPARTMENT - GENERAL EXPENSE FUND: From moneys received on account of taxes levied and other available sources, there is Hereby appropriated to the General Expense Fund Administrative Departments and Sundries, the sum of \$34,306.45.

B. LAW ENFORCEMENT: From the moneys received on account of taxes levied and other available sources there is hereby appropriated to the Law Enforcement, the sum of \$22,500.00.

C. FIRE DEPARTMENT: From the moneys received on account of taxes levied and other available sources there is hereby appropriated to the Fire Department the sum of \$17,900.00.

D. WATERWORKS DEPARTMENT: From the revenue derived from the waterworks system of the City during the calendar year 1963, the moneys now on hand in the waterworks fund, and other revenues available, there is hereby appropriated the sum necessary to defray the expense of operating and maintaining said system during the calendar year 1963, and from such revenue, and for said proposes, there is hereby appropriated the sum of \$32,000.00.

E. IRRIGATION DEPARTMENT: All moneys received on account of the irrigation system of the City of Rexburg, and distribution of water thereby to the inhabitants of the City, are hereby appropriated to the City Ditch Fund for the payment of salaries, wages and other necessary expense of operation and maintenance of said irrigation system, there is hereby appropriated to the Ditch Fund for such purposes from moneys not otherwise appropriated, the sum of \$3,000.00.

F. STREETS AND ALLEYS: From moneys received on account to taxes levied thereof and other revenues available, there is hereby appropriated to the Streets Department of the City of Rexburg, for maintenance and improvement of Parks, the sum of \$10,500.00.

H. STREET LIGHTING DEPARTMENT: From the moneys received on account of taxation and other sources available there is hereby appropriated to the Street Lighting Department, for the payment of the cost of street lighting and maintenance, the sum of \$9,500.00.

I. AIRPORT DEPARTMENT: From moneys received from taxation and other available sources there is hereby appropriated to the Airport Department Fund for general operating expenses, the sum of \$500.00.

J. MUNICIPAL PARK IMPROVEEMNT BOND & REDEMPTION FUND: From moneys received on account of taxes levied thereof and other available source, there is hereby appropriated for the payment of interest on outstanding general obligation bonds of said city known as Municipal Park Improvement Bonds, and the payment of maturing installments on such indebtedness, the sum of \$3012.50.

K. BOND INTEREST AND REDEMPTION FUND: From money received on account of taxes levied thereof and other available sources, there is hereby appropriated for the payment of interest on outstanding general obligation bonds of said City and the payment of maturing installments on such indebtedness, the sum of \$12,932.60.

L. POLICE RETIREMENT FUNDS: From the moneys received on account of taxed levied, there is hereby appropriated to the Police Retirement Fund, for the payment of retirement benefits, the sum of \$3,066.00.

M. FIREMEN'S RETIREMENT FUND: From the moneys received on account of taxes levied, there is hereby appropriated to the Firemen's Retirement Fund for payment of such benefits the sum of \$750.00.

N. GENERAL FUND: All revenue of the City of Rexburg, Idaho, received during the calendar year 1963 not hereby otherwise appropriated is hereby appropriated to the General Fund of the City.

O. RECREATION DEPARTMENT: All moneys received on account of taxes levied and other sources available, there is hereby appropriated to the Recreation Department of the sum of \$1,000.00.

P. HELATH AND SANITATION DEPARTMENT: From moneys received on account of taxes levied thereof and other revenues available, there is hereby appropriated to the Health and Sanitation Department, for the maintenance of Public Physician and Nurse, garbage removal and dump ground labor and expense, the sum of \$17,600.00.

Q. RECREATION DEPARTMENT: All moneys received on account of taxes levied and other sources available, there is hereby appropriated to the Recreation department the sum of \$1,000.00.
