



ORDINANCE NO. 463

AN ORDINANCE OF THE CITY OF REXBURG, MADISON COUNTY, IDAHO PROVIDING FOR THE VACATING, ANNULLING, AND DISCONTINUING OF PUBLIC STREETS THE STREETS KNOWN AND REFERRED TO AS THIRD SOUTH FROM CENTER STREET TO FIRST WEST,, FIFTH SOUTH BETWEEN FIRST WEST AND SECOND EAST, AND EVERYTHING SOUTH OF FOURTH SOUTH AND FIRST EAST, AND PROVIDING FOR THE REVERTING OF THE TITLE TO SAID STREETS SO VACATED TO THE ABUTTING PROPERTY OWNERS AND PROVIDING THAT THE MAYOR AND CITY CLERK BE AUTHORIZED TO CONVEY BY DEED THE INTEREST THAT THE SAID CITY OF REXBURG, MADISON COUNTY, IDAHO, HAS IN AND TO SUCH STREETS TO THE ABUTTING PROPERTY OWNERS.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG:

WHEREAS, Third South from Center Street to First West, Fifth South between First West and Second East, and everything south of Fourth South on First East is not necessary for the use of the City of Rexburg, Madison County, Idaho, and is not required for city purposes, and

WHEREAS, It appears to the Mayor and City Council that it would be for the best interests of the City of Rexburg, Madison County, Idaho, to have said streets vacated and annulled and conveyed to the abutting property owners,

NOW, THEREFORE, IT IS ORDERED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG:

SECTION I: That the following described streets, to-wit:

Third South from Center Street to First West, Fifth South between First West and Second East, Everything South of Fourth South on First East

be, and the same are hereby vacated, annulled and discontinued as City streets of the City of Rexburg, Madison County, Idaho.

SECTION II: That title to said streets so vacated shall revert to the adjoining property owners.

SECTION III: That the Mayor and City Clerk be, and they are hereby authorized to convey by deed to the adjoining property owners, whatever interest the City of Rexburg, Madison County, Idaho, may have in and to the said streets so vacated.

SECTION IV: This ordinance shall take effect and be in full force and effect from and after its passage, approval and due publication as provided by law.
