**ORDINANCE NO 597**

**AN ORDINANCE AMENDING AND CHANGING THE ZONING MAP OF THE CITY OF REXBURG, IDAHO, TO PROVIDE THAT CERTAIN PROPERTY HEREINAFTER DESCRIBED LOCATED WITHIN THE CITY LIMITS OF REXBURG, MADISON COUNTY, IDAHO, BE ZONED R1 RESIDENTIAL.**

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

**SECTION I:** That the zoning map of the City of Rexburg, Idaho, certified by the Mayor and Council of the City of Rexburg, Idaho, and filed with the Clerk thereof, be, and the same is hereby amended to provide that the following described property situated in Rexburg, Madison County, State of Idaho, to-wit:

A parcel of land situated in the City of Rexburg, State of Idaho, Section 29, Township 6 North, Range 40 East of the Boise meridian more particularly described as follows: Beginning at a point that is 1318.5 feet East and 1321.5 feet South of the Northwest corner of the Southwest Quarter of Section 29, Township 6 North, Range 40 East, Boise Meridian; thence South for a distance of 1320.0 feet more or less to the South line of Section 29; thence West along said section line for a distance of 660.0 feet more or less to a sixteenth line of said section; thence North along said sixteenth line for a distance of 1320.0 feet more or less; thence East for a distance of 660.0 feet more or less to the True Point of Beginning. be, and the same is hereby zoned R1 Residential.

**SECTION II:** That the zoning map showing this amendment shall be certified and declared to be the official zoning map of the City of Rexburg by a certificate of the Mayor and Council of the City of Rexburg endorsed thereon.
