



ORDINANCE NO. 653

AN ORDINANCE REPEALING ORDINANCE NO. 616 OF THE CITY OF REXBURG, IDAHO, AND ADOPTING THE UNIFORM PLUMBING CODE, COPYRIGHTED BY THE INTERNATIONAL ASSOCIATION OF PLUMBING AND MECHANICAL OFFICIALS, 1982 EDITION, FOR THE CITY OF REXBURG, IDAHO; PROVIDING FOR THE ADMINISTRATIVE AUTHORITY; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I: That Ordinance No. 616 of the City of Rexburg, Idaho, be, and the same is hereby repealed.

SECTION II: That certain document known as the Uniform Plumbing Code, 1982 Edition, copyrighted by the International Association of Plumbing and Mechanical Officials is hereby adopted as the Plumbing Code of the City of Rexburg, Idaho, together with amendment and revisions thereof with the inclusion of appendices. Said Code provides the minimum requirements and standards for the protection of public health, safety and welfare, and the provisions of the Code shall apply to the erection, installation, alteration, addition, repair, relocation, replacement, maintenance or use of any plumbing system except as otherwise provided in said Code.

SECTION III: The Administrative Authority shall be the City Council of the City of Rexburg, Idaho, and such authority may appoint and employ such assistants, deputies, inspectors or other employees as are necessary and authorized to carry out the functions of said Code.

SECTION IV: From and after May 24, 1983, applicants shall pay to the City Clerk, fees established by the Council.

SECTION V: There has been on file, and there shall hereafter be kept on file, in the office of the Clerk, three (3) copies of said Uniform Plumbing Code, 1982 Edition, duly certified by the Clerk, for use and examination by the public.

SECTION VI: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION VII: This ordinance shall be in full force and effect from and after its passage, approval and due publication as provided by law.
