



ORDINANCE NO. 668

AN ORDINANCE AMENDING AND CHANGING THE ZONING MAP OF THE CITY OF REXBURG, IDAHO, AND PROVIDING THAT THE ZONED DESIGNATIONS OF THAT CERTAIN PROPERTY HEREINAFTER DESCRIBED, SITUATE IN REXBURG, MADISON COUNTY, IDAHO, BE CHANGED AS HEREINAFTER DESIGNATED; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

SECTION I: That the zoning map of the City of Rexburg, Idaho, which is filed with the clerk thereof, be, and the same is hereby amended and changed to provide that the hereinafter described property situate in Rexburg, Madison County, State of Idaho, be zoned as hereinafter set forth.

- A. The following described property located in the Mill Hollow Mobile Home Park in Rexburg, Madison County, Idaho, is hereby zoned R-3:

Commencing at a point that is 1642.79 feet north of the Southeast Corner of the Southwest Quarter of Section 20, Township 6 North, Range 40 East, Boise Meridian, Madison County, Idaho, and running thence N. 89E55'28" E. 1003.55 feet; thence South 82.18 feet; thence West 1003.55 feet; thence North 80.86 feet to the point of beginning.

- B. The following described property located in Rexburg, Madison County, Idaho, is hereby zoned R-1:

Commencing at a point that is West along the South Line of Section 29, 1122 feet more or less from the Southeast Corner of the Southwest Quarter of Section 29, Township 6 North, Range 40 East, Boise Meridian, and running thence West, along the South Line of Section 29, 198 feet more or less to a sixteenth line; thence North along said sixteenth line, 1320 feet more or less to a sixteenth line; thence East, along said sixteenth line, 198 feet more or less; thence South, 1320 feet more or less to the point of beginning.

- C. The following described property which is located south of the old Rexburg Golf Course in Rexburg, Idaho, is hereby zoned R-1:

Commencing at the Northeast Corner of the Northwest Quarter of the Northeast Quarter of Section 25, Township 6 North, Range 39 East, Boise Meridian, and running thence West, along the Section Line 990 feet; thence South, 660 feet; thence West to the Quarter Line 330 feet more or less; thence South, along said Quarter Line, 990 feet; thence East, 629 feet; thence North 330 feet; thence East 629 feet more or less to the sixteenth line; thence North, along said sixteenth line, 1320 feet more or less to the point of beginning.

SECTION II: That a new zoning map showing this amendment shall be certified to and declared to be the official zoning map of the City of Rexburg by a certificate of the Mayor and Council of the City of Rexburg endorsed thereon.

SECTION III: This ordinance shall become effective upon its passage, approval and publication.
