



**ORDINANCE NO. 739**

**AN ORDINANCE AMENDING AND CHANGING THE ZONING MAP OF THE CITY OF REXBURG, IDAHO, AND PROVIDING THAT THE ZONED DESIGNATIONS OF THAT CERTAIN PROPERTY HEREINAFTER DESCRIBED, SITUATE IN REXBURG, MADISON COUNTY, IDAHO, BE CHANGED AS HEREINAFTER DESIGNATED; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.**

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, IDAHO:

**SECTION I:** That the zoning map of the City of Rexburg, Idaho, which is filed with the clerk thereof, be, and the same is hereby amended and changed to provide that the hereinafter described property situate in Rexburg, Madison County, State of Idaho, be zoned as hereinafter set forth.

A. The following described property located in Rexburg, Madison County, Idaho, is hereby zoned H.D.R.:

TRACT 1: Lots 2 and 3, Block 13 of the Parker Addition to the City of Rexburg, Madison County, Idaho, as per the recorded plat thereof. LESS: The West 108 feet of the South 10 feet thereof..

TRACT 2: Commencing at the Southwest corner of the North half of Lot 6 in Block 13 of the Parker Addition to the City of Rexburg, Madison County, Idaho, as per the recorded plat thereof, and running thence East 330 feet; thence North 82.5 feet; thence West 222 feet; thence South 66 feet; thence West 108 feet; thence South 16.5 feet to the true point of beginning.

**SECTION II:** That a new zoning map showing this amendment shall be certified to and declared to be the official zoning map of the City of Rexburg by a certificate of the Mayor and Council of the City of Rexburg endorsed thereon.

**SECTION III:** This ordinance shall become effective upon its passage, approval and publication.
