ORDINANCE NO. 763

AN ORDINANCE AMENDING ORDINANCE NOS. 755 AND 756, CORRECTING THE LEGAL DESCRIPTION OF THE LANDS ANNEXED TO THE CITY OF REXBURG, IDAHO; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF REXBURG, AS FOLLOWS:

SECTION I: That the legal description contained in Section I. of ordinance 755, adopted on February 2, 1994, and in Section I. of Ordinance 756 adopted on April 20, 1994, be amended and corrected to read as follows:

Beginning at the Northeast corner of the Northwest 1/4, Section 25, Township 6 North, Range 39 East, Boise meridian, Madison County, Idaho, thence along the North line of section 25, S 89 o 50'06"W, 560.93 feet; thence S 6 o 41'19"W, 697.99 feet along the east right-of-way line of ramp "A-B" of the Main Street exit of State Highway 20; thence N 89 o 50' 06"E, 643.93 feet to a point on the north-south centerline of Section 25; thence N 0 o 08'25"W, 692.99 feet to the Northeast corner of the Northwest 1/4 sand Section 25, the point of beginning, and containing 9.00 acres.

SECTION II: That all other sections of Ordinance 755 and 756 shall remain in full force and effect, amended only by the correction in the foregoing legal description of the real property annexed to the City.

SECTION III: This ordinance shall be in full force and effect from and after its passage, approval and due publication.
