



**ORDINANCE NO. 785**

**AN ORDINANCE ADOPTING THE NATIONAL ELECTRICAL CODE, 1996 EDITION, REGULATING AND CONTROLLING THE DESIGN, INSTALLATION, QUALITY OF MATERIALS, ERECTION, INSTALLATION, ALTERATION, REPAIR, LOCATION, RELOCATION, REPLACEMENT ADDITION TO, USE OR MAINTENANCE OF ELECTRICAL SYSTEMS, WIRES, CIRCUITS, MOTORS, OR OTHER MISCELLANEOUS ELECTRICAL EQUIPMENT IN THE CITY OF REXBURG; PROVIDING FOR THE ISSUANCE OF PERMITS AND COLLECTION OF FEES THEREFORE; REQUIRING COPIES OF SAID CODE TO BE KEPT IN THE OFFICE OF THE CITY CLERK; PROVIDING FOR A PENALTY FOR THE VIOLATION OF THIS ORDINANCE AND OR SEVERABILITY; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.**

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF REXBURG, IDAHO:

**SECTION I:** That the document known as the National Electrical Code, copyrighted by the National Fire Protection Association, 1996 Edition, together with the amendments and revisions thereof, with the inclusion of appendices, is hereby adopted as the Electrical Code of the City of Rexburg, Idaho. Said Code provides for regulating and controlling the design, installation, quality of material, erection, installation, alteration, repair, location, relocation, replacement, addition to, use or maintenance of electrical systems, wires, circuit, motors, or other miscellaneous electrical equipment except as otherwise provided in said Code.

**SECTION II:** There has been on file and there shall hereafter be kept on file, in the office of the Clerk or City Engineer three (3) copies of said National Electrical Code, 1996 Edition, duly certified by the Clerk, for use and examination by the public.

**SECTION III:** The administrative authority shall be the City Council of the City of Rexburg, Idaho, and such authority may appoint and employ such assistants, deputies, inspectors or other employees as are necessary and authorized to carry out the functions of said Code.

**SECTION IV:** All applicants shall pay to the City Clerk, fees, if any are established by resolution of the City Council.

**SECTION V:** Any violation of this Chapter by a person, firm or corporation shall, upon conviction thereof, be punishable by a fine not to exceed Three Hundred Dollars (\$300.00) or imprisonment for not more than six (6) months or by both such fine and imprisonment for any single violation.

**SECTION VI:** The sections of this Ordinance are severable and the invalidity of a section shall not affect the validity of the remaining sections.

**SECTION VII:** All ordinance or parts of ordinances in conflict herewith are hereby repealed.

**SECTION VIII:** This Ordinance shall become effective upon its passage, approval and publication in the manner provided by law.
