**SUMMARY OF ORDINANCE 854
OF THE CITY
OF REXBURG, IDAHO**

PUBLIC NOTICE IS HEREBY GIVEN that the City of Rexburg, Idaho, adopted at its regular meeting of June 12, 2001, that Ordinance No. 854 entitled:

AN ORDINANCE PROVIDING FOR THE CREATION OF PLANNED RESIDENTIAL DEVELOPMENT AS A CONDITIONAL USE IN CERTAIN ZONES WITHIN THE CITY OF REXBURG; ESTABLISHING THE PURPOSE OF PLANNED RESIDENTIAL DEVELOPMENT; SETTING FORTH THE PROCESS FOR OBTAINING THE NECESSARY PERMIT FOR PLANNED RESIDENTIAL DEVELOPMENT; PROVIDING FOR THE RULES AND REGULATIONS THAT SHALL GOVERN PLANNED RESIDENTIAL DEVELOPMENT; ESTABLISHING THE BONDING PROCEDURE INVOLVED WITH PLANNED RESIDENTIAL DEVELOPMENT; AMENDING ORDINANCE 725 AS NECESSARY TO ALLOW FOR PLANNED RESIDENTIAL DEVELOPMENT; REPEALING ALL OTHER ORDINANCES OR PORTIONS THEREOF IN CONFLICT HERewith; AND PROVIDING FOR THE EFFECTIVE DATE OF THIS ORDINANCE.

The effective date of the Ordinance is the date of its passage, approval and publication. A copy of the full text of the Ordinance is available at City Hall, 12 North Center, Rexburg, Idaho. Examination or copies may be requested in writing or in person during regular business hours of the City Clerk, from 8 a.m. to 4 p.m. pursuant to the Open Records Act, Idaho Code, Title 9, Chapter 3.
