Resolution 08-07-1963

A RESOLUTION FIXING THE TIME WHEN OBJECTIONS TO THE ASSESSMENT ROLL FOR LOCAL IMPROVEMENT DISTRICT NO. 16 MADE OUT BY THE COMMITTEE ON STREETS OF THE CITY COUNCIL TOGETHER WITH THE CITY ENGINEER, WILL BE HEARD, AND CAUSING SUCH ROLL TO BE FILED IN THE OFFICE OF THE CITY CLERK.

WHEREAS, the Committee on Streets of the City Council of the City of Rexburg, together with the City Engineer, has made out an assessment roll for Local Improvement District No. 16, in Rexburg, Idaho, for construction and reconstruction of curbs and gutters, and the construction of drainage works incidental to said improvements within said District, in accordance with the provisions of Ordinance No. 438, passed and approved the 3rd day of July, 1963, and section 50-2915 Idaho Code, and has certified said roll to said City Council.

AND WHEREAS, said City Council has caused said roll to be filed in the office of the City Clerk on the 7th day of August 1963.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF REXBURG, IDAHO:

Section 1. That Wednesday, the 28th day of August, 1963, at 8 o'clock P.M. at the City Hall in the City of Rexburg, Idaho, be and the same hereby is fixed as the time when the City Council will hear and consider objections to said assessment roll by parties aggrieved by such assessments.

Section 2. That the City Clerk shall give notice by publication in the official newspaper of the City of Rexburg, Idaho, the Rexburg Standard, published weekly, in a least one issue at least twelve days before the said 28th day of August, 1963, and by mailing a copy of such notice to the property owners in said district, that such assessment roll is on file in her office, the date of filing the same, and said notice shall state the time at which the Council will hear and consider objections to said assessment roll by the parties aggrieved by such assessments. Said notice shall be substantially the following for, to-wit;

NOTICE IS HEREBY GIVEN that the assessment roll for Local Improvement District No. 16 in Rexburg, Idaho, for construction and reconstruction of curbs and gutters and the construction of drainage works incidental to said improvements within said district, was filed in my office on the 7th day of August, 1963, and is now on file therein.

The owner of owners of any property which is assessed in said assessment roll, whether named or not in said roll, may within ten days from the first publication of this notice on August 15, 1963, file with me his objections in writing to said assessment.

The City Council will meet to hear and consider objections to said assessment roll by the parties aggrieved by such assessments on Wednesday, the 28th day of August, 1963, at 8 o'clock P.M. at the City Hall in the City of Rexburg, Idaho.

Section 3. That the owner of owners of any property which is assessed in such assessment roll, whether named or not in such roll, may, within ten days from the first publication provided for herein, file with the clerk his objections in writing to said assessment.

Section 4. That all action here for taken by said City and the officers of said City directed toward said advertisement be, and the same is here by ratified, approved and confirmed.
