

RESOLUTION No. 2003-09

A RESOLUTION FOR APPOINTMENT OF JUDGES AND CLERKS FOR GENERAL MUNICIPAL ELECTION TO BE HELD NOVEMBER 4, 2003.

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF REXBURG, IDAHO, THAT:

SECTION 1: Under Section 50-409 of the Idaho Code, it is required that the City Clerk appoint an Election Judge and such other workers as may be necessary for each Voting Precinct within the City. Following is a list of names recommended for these positions:

SECTION 2: Under Section 50-409, Idaho Code, Compensation for the election judges and clerks shall be not less than the minimum wage as prescribed by laws of the state of Idaho. It is resolved the compensation be set at \$110.00 per day for judges and \$90.00 per day for clerks.
